**MODIFIED RECOGNITION ORDER**

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993, VIVEK JYOTI D.ED. COLLEGE RUN BY SHRI BABAURAO KADU SMRITI SHIKSHA SAMITI, WARD NO.24, SURABHI NAGAR, BALAGHAT 491001 MADHYA PRADESH (Code No. APW02130/222102/223242) had submitted on 31-Oct-05 the application to the Western Regional Committee of the NCTE for grant of recognition for starting the D.Ed. Course with an annual intake of 100.

The institution was granted conditional recognition vide order No. WRC/NCTE/2006-2007/c-20869-20871 dated 26/30 July, 2007 for D.Ed. programme with an intake of 100 seats.

The WRC in its 152<sup>nd</sup> meeting considered the representations of the institution and decided to modify the conditional recognition order maintaining the status quo of the intake of 100 seats granted vide order no. WRC/NCTE/2006-2007/c-20869-20871 dated 26/30 July, 2007.

**NOW THEREFORE**, the conditional recognition order no. WRC/NCTE/2006-2007/c-20869-20871 dated 26/30 July, 2007 may be treated as formal recognition order.

The institution shall ensure that the required number of academic staff for conducting the course is always in position.

The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its Official website.

If, at any time, either on *sue-moto* inspection or on any representation received from any person, the WRC, NCTE is satisfied that the institution has contravened any of the provisions of the NCTE Act, or the rules, regulations, orders made or issued there under or any condition subject to which the recognition/permission was granted, the recognition/permission may be withdrawn under the provisions of Section 17 (1) of the NCTE Act.
